# THE ANNE L. BARLOW RAMSAY ANNUAL GRANT ~ \$25,000

### *Vision: Dreams In Action*

*It has been Dr. Anne Ramsay's vision to enhance the sport of Dressage. Now, she transforms that dream into action with the "Anne L. Barlow Ramsay Annual Grant." The purpose is to showcase talented American-bred horses ridden by United States citizens, by providing funds to train and compete in Europe. Her plan is long-range; it will help today, and tomorrow, as you will read in this application brochure.*

### *Dr. Ramsay's Legacy*

Dr. Ramsay's dream to advance equestrian sport took shape in 1998, when she established a Charitable Remainder Unitrust, funded with \$254,000 of highly appreciated Abbott Laboratory stock. She wanted to provide financial backing for a designated horse and rider with a ten-year income stream. She worked with John Boomer, then President and CEO of The Dressage Foundation, to create the Unitrust and put her plan into action. There have been many beneficiaries: 1) Her horse and rider had the support of a ten-year income stream, paid monthly through 2008; 2) Dr. Ramsay gained solid tax advantages by avoiding the federal and state capital gain taxes on the appreciated value of the stock, and she received a substantial charitable contribution income tax deduction, thereby reducing her income tax payable. 3) The sport of Dressage gains by receiving future annual grants of \$25,000, to send American-bred horses to Europe for upper level training and competition. Dr. Ramsay designated The Dressage Foundation as sole, irrevocable charitable remainderman to whom the Unitrust "remainder" was paid in January of 2009. This funding



will make these future training grants possible.

AND, there's a Part II to Dr. Ramsay's visionary plan: Working with The Dressage Foundation, she created a second ten-year term Charitable Remainder Unitrust, with the same conditions and monetary value, extending the reach of her good training support well out into future years. John Boomer said of Dr. Ramsay's Plans, "Anne Ramsay's creative, distinctive gift is remarkable for its longevity – it will be helping Dressage riders far out into future years."

The Anne L. Barlow Ramsay Annual Grant will be managed and administered by The Dressage Foundation. The Fund was established by a written Board Resolution, which spells out the Fund's purpose, policies and procedures. This puts on permanent file a stewardship governance road map, to guide future Management and Boards in carrying out Dr. Ramsay's designated plans. A Selection Committee comprised of distinguished, experienced Dressage leaders will review the applications, and choose the recipient each year, subject to the approval of The Dressage Foundation's Board of Directors.

The purpose of this fund is to showcase talented American-bred horses ridden by United States citizens by providing them with funds to train and compete in Europe. The horse and rider applicants will be competing successfully at Prix St. Georges or higher, and demonstrate an ability to move forward into High Performance competition. Further, the successful applicant will demonstrate an ability to be an ambassador for the American-bred horse in Europe.

The Dressage Foundation and the national Selection Committee for the Anne L. Barlow Ramsay Grant, look to applicants to prepare a thorough and

complete application, to make the best presentation you can.

The list of subject categories on the facing page must be included in your application, which is to be typed or computer generated. No handwritten applications will be accepted. The Dressage

Foundation requires **six (6)** complete sets of your application sent to the Foundation office by October 25th of each year.

We will not accept applications after this date.

The Dressage Foundation reserves the right NOT to award this Grant in any year that, in the opinion of the Selection Committee, appropriate applications have not been received, leaving that year's grant money in the Fund.

My training will commence after January of next year, with my chosen and approved European trainer in Europe with a horse bred in the United States, with whom I am currently competing. I agree to use the funds within two years following the announcement date. I understand that I will receive an initial grant of \$20,000 one month before I leave for Europe, and \$5,000 at the completion of my training and the submission of a written report to The Dressage Foundation. The report will include details of my training program, a financial summary of expenses, and documentation and results of competitions attended. I will send this written summary to The Dressage Foundation within three months after I have returned from training. I attest that I am a citizen of the United States of America.*

# Application Requirements

- PLEASE attach a copy of your USDF and USEF membership cards.
- PLEASE attach copies of breed registration papers demonstrating that the horse you intend to train and compete with in Europe is American-bred.
- PLEASE attach a copy of the identification section of the horse's passport.
- PLEASE attach documentation that you and the horse have achieved at least three scores of 65% or higher at Prix St. Georges or above. Such documentation may include copies of the front of score sheets, USDF show reports or other confirmable proof of scores. Please provide a brief summary of your competition history with the horse, and the goals you would wish to achieve during your period of training and competing in Europe.
- PLEASE read the "Criteria to Compete in Foreign CDIs, CDIOs, CDI-Ws," found on the USEF website, <http://www.usef.org>. Your signature on the facing page will attest that you have read and understand the criteria, and intend to comply and compete in European CDI competition.
- If you own the horse, please attach proof of ownership. If you do not own the horse, please provide a letter from the horse's owner indicating that you have permission to take the horse to Europe to train and compete and that the owner has no present plans to sell the horse, remove the horse from your care and custody or to provide the horse to another rider.
- PLEASE present a training plan indicating the name, contact information and address of the trainer in Europe with whom you wish to train, the competitions in which you would like to participate, and the approximate dates of your anticipated training.
- PLEASE provide a letter from the trainer with whom you will be working, indicating that you have been accepted for training, and the approximate costs of the training program.
- PLEASE provide a detailed, line item budget of your anticipated costs, including transportation, training fees, board for the horse, lodging and board for yourself and, if appropriate, a groom, competition fees, and other anticipated expenses. We do not anticipate that the grant will necessarily cover all expenses, so please indicate to the committee how you will handle the balance of these expenses. Since you will, of necessity, be taking a prolonged sabbatical from your usual employment, please indicate how you will deal with the economic repercussions of such an absence.
- PLEASE provide two reference letters from trainers, instructors or dressage contacts who will vouch for your riding skills, your desire to improve, your suitability to serve as an ambassador for American breeders of dressage horses and your potential to move up into international competition. It is recommended that your references send their comments on their letterhead, if available.
- PLEASE send six (6) DVDs of you and your horse(s) so the Selection Committee can see you in action.
- PLEASE sign the commitment statement located on the facing page. This is part of your application. Please include this sheet with the other information.

For applicants to be considered, **six** copies of completed applications, accompanied by all required attachments, must be received at The Dressage Foundation office on or before October 25th of each year.

## *A Word About Dr. Ramsay*

**D**r. Anne L. Barlow Ramsay is a Renaissance woman – a wife, mother, medical doctor, business executive, volunteer, world-traveler, and equestrienne. She was born in England in 1925, and graduated from the University of London with an M.D. equivalent. She also earned a Diploma in Child Health from Royal Colleges in England, and Master of Public Health from Yale University. She moved to Canada in 1951 as a Rotary Foundation Fellow, and was licensed in Michigan, Pennsylvania and Illinois.

In 1963, she joined Abbott Laboratories as a medical writer, and rose to become Vice President of Medical Affairs for the Hospital Products Division. In 1984, she launched her own consulting business in pharmaceutical research, which is on going today. Dr. Ramsay has served as

President of the American Medical Women's Association, and Vice President for North America for the Medical Women's International Association. She has been chair of the American Medical Women's Foundation and Chair of the American Women's Hospitals Service for thirteen years until 1997, and again in 2006 to present. Dr. Ramsay chaired the Governing Council of AMA Senior Physicians Group from 1997- 2005.

Dr. Ramsay has been a horse woman for forty years, and owns a sport horse breeding operation in Wisconsin with her daughter, Barbara Cadwell. Dr. Ramsay serves on the Finance Committee of The Dressage Foundation. She and her horse Fridjoff, proudly rode for Century Club membership Team # 27 (2003) sponsored by The Dressage Foundation.
