In 1998, The Dressage Foundation received a \$100,200 contribution from an anonymous Donor. The Donor's wish was for The Dressage Foundation to establish the gift in Endowment Fund form, whereby the principal will be kept invested permanently, with the earnings available each year for the purpose of providing continuing education for Dressage Instructors and Adult Amateurs.

Endowment Funds are like a wellspring – a continuous source of supply – as the earnings stream flows on into perpetuity for this good purpose in Dressage.

The Dressage Foundation Board of Directors, working with the Donor decided to establish this fund as the "Founders' Endowment Fund," in honor of those persons who came to Lincoln, Nebraska in 1973 at the invitation of Lowell Boomer to form the United States Dressage Federation. The names of those persons, to whom the Dressage community owes so much gratitude, are listed in this brochure.

The Dressage Foundation will actively solicit other donations to this important Fund, so that as the principal base of the Fund grows in the future, so will the earnings
